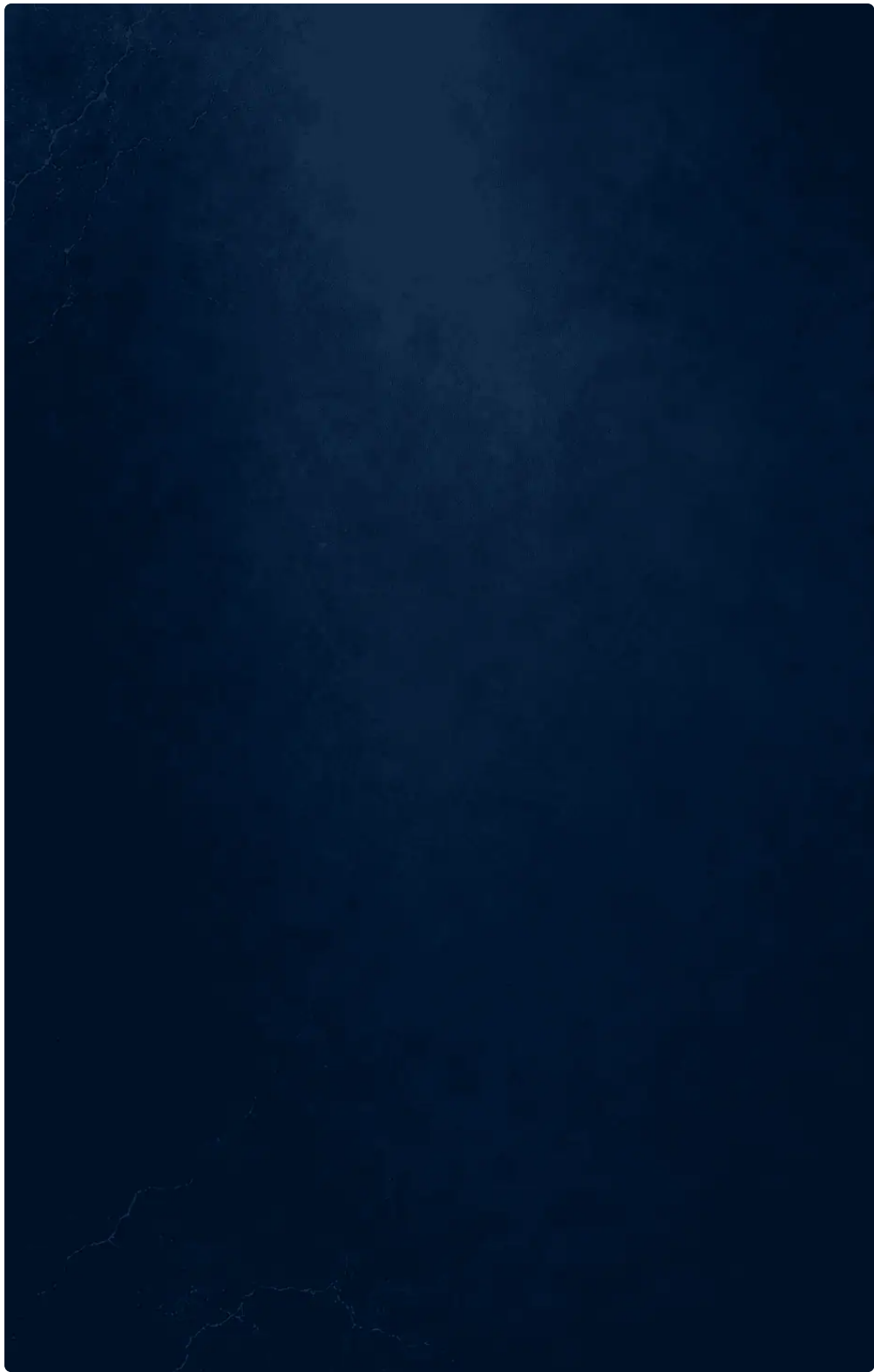

A strong car accident claim depends on evidence that helps answer several basic questions: How did the collision happen? Who was responsible? What injuries resulted? What treatment was required? What financial and personal losses followed?

No single document proves every part of a case. Instead, a clear claim is usually built from multiple sources of information that support one another. [Puyallup car accident attorney John Forsythe](#) helps injured clients gather and organize evidence so the insurance company can see the full impact of a collision rather than only isolated bills or statements.

Photos and Video From the Accident Scene

Visual evidence can preserve details that may disappear quickly. When it is safe to do so, photographs can show vehicle damage, the position of the vehicles, debris, traffic signals or signs, lane markings, weather conditions, skid marks, and visible injuries.

Photos taken later can also be useful. Vehicle damage may be repaired, bruising can change, and the physical effects of an injury can evolve. Keeping original files and dates can help preserve the timeline.

If a nearby business, residence, dash camera, or traffic system may have captured the collision, that footage can be important. Because video is not always retained indefinitely, identifying potential sources early may matter.

Witness Information and Police Records

Independent witnesses may be able to describe what they saw before, during, or immediately after a crash. Names, phone numbers, email addresses, or other contact information can make it possible to follow up later.

When law enforcement responds, the resulting collision report may contain driver information, insurance information, statements, a diagram, observations, or other details. A report is one piece of evidence rather than the entire case, but it can help establish the basic record of the incident.

Medical Records That Document the Injury

Medical documentation often becomes central to an injury claim. Records may identify symptoms, diagnoses, examinations, imaging, treatment recommendations, referrals, restrictions, and the patient's progress over time.

The issue is not simply the total amount of medical bills. The records help explain [Car accident lawyer Puyallup](#) the connection between the accident and the injury, the type of treatment required, whether symptoms improved or persisted, and whether future care may be needed.

Keep copies of bills, explanation-of-benefits statements, prescriptions, therapy records, and other medical documents you receive. If a provider gives written work restrictions or activity restrictions, preserve those as well.

Records Showing Lost Income or Work Limitations

If an accident causes missed work, reduced hours, or other employment consequences, documentation can help establish that loss. Useful records may include pay stubs, employer correspondence, time-off records, tax documents, schedules, or written work restrictions.

For self-employed people, proving income loss may require different records, such as invoices, business records, contracts, or historical earnings information. The appropriate evidence depends on how the person earns income and how the injury affected the work.

Insurance and Claim Correspondence

Save letters, emails, text messages, claim numbers, adjuster contact information, recorded-statement requests, estimates, and settlement communications. Keeping the insurance record organized can help show what information was provided and when.

The Washington State Office of the Insurance Commissioner recommends keeping documentation connected to an auto claim and reviewing the policy's claims process. Its [auto claim guidance](#) provides general information for Washington policyholders.

Evidence of How the Injury Changed Daily Life

Not every consequence of an accident appears on a medical bill. An injury may interfere with sleep, household responsibilities, driving, exercise, hobbies, childcare, travel, or ordinary movement.

Contemporaneous notes can help preserve details about symptoms, limitations, important appointments, missed activities, and changes in daily routine. The purpose is not to exaggerate the injury. It is to create an accurate record of effects that may otherwise be difficult to reconstruct months [Personal Injury Lawyer](#) later.

Vehicle Repair and Property-Damage Records

Repair estimates, photographs, total-loss documents, towing receipts, rental records, and other vehicle information can help establish the physical consequences of the collision. Vehicle damage does not by itself determine whether someone was injured, but it can be part of the overall evidence about the crash.

The Office of the Insurance Commissioner notes that some property claims, including diminished-value claims, require supporting documentation. Drivers should keep records connected to repairs and claim payments.

Evidence Is Especially Important When Fault Is Disputed

When the drivers disagree about what happened, photographs, witness statements, video, road evidence, and records may become even more important. Washington's comparative-fault statute, [RCW 4.22.005](#), provides that fault assigned to an injured claimant can proportionately reduce compensatory damages.

That is one reason it is helpful to preserve objective evidence rather than relying entirely on memory or competing statements.
