

What the Anion Gap Represents

The **anion gap** is a practical way to estimate the balance between measured cations and measured anions in the blood. In practical terms, it helps clinicians and learners evaluate whether an **electrolyte panel** indicates an acid-base problem, especially **metabolic acidosis**. The concept is straightforward: routine labs measure several **electrolytes**, including **sodium** and **chloride**, but they do not directly measure every charged particle in circulation.

Common Causes of High Anion Gap Acidosis
