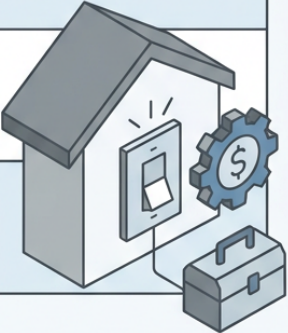
How Does Permit Coordination Factor Into Hourly Rates?
