

If a dog bit you around Atlanta, the rules may not be what you assume.

Certain states impose liability regardless of the animal's history. Georgia is not one of them. The claim generally turns on whether the owner [Additional hints](#) knew the animal was dangerous, or whether a leash law was being broken at the [truck accident lawyer](#) time.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

This evidence does not last. Prior complaints and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.
