

If you were hurt by electrical contact in Georgia, the answer is rarely a single company.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it prevents you from suing the employer directly. It does not bar a claim against a third party whose conduct created the hazard.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, none of which [truck accident lawyer](#) an injured worker can obtain by asking.
