They will prepare a Party Wall Honor, which is a legitimately binding document laying out the regards to the work and how any kind of conflicts will certainly be addressed. If either celebration is miserable with the award, they can appeal it within 2 week. Serving the notice needs a two-month notification period, and disagreements may need added time to deal with.
