

What the Anion Gap Measures

The **anion gap** is a calculated value used in lab medicine to assess the difference between routinely measured cations and anions in **electrolytes**. 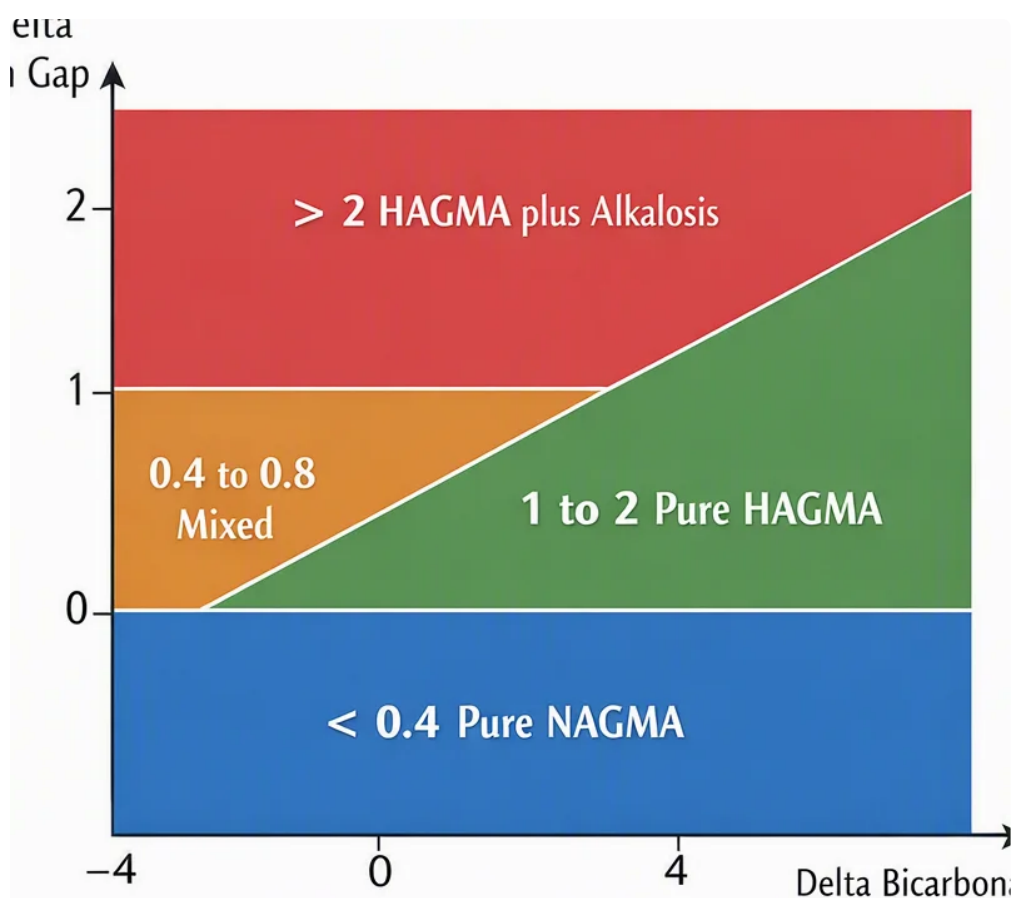
Common Causes of an Elevated Anion Gap
