

If a dog bit you in Atlanta, the rules may not be what you assume.

In some places an owner is liable automatically. Georgia is not one of them. The claim generally turns on whether the owner knew the animal was dangerous, or whether a leash law was being broken at the time.

The knowledge route is hard to prove. Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

A leash law violation is often the clearer path, which is why the first **injury lawyer in Atlanta** questions are about where the dog was and whether a complaint was ever filed.

Records disappear quickly here. County records and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.

How long do I have to file an injury claim in Georgia?

Georgia generally gives an injured person two years from the date of the injury to file a personal injury lawsuit, and a claim against a city, county or state agency can require written notice far sooner than that.
