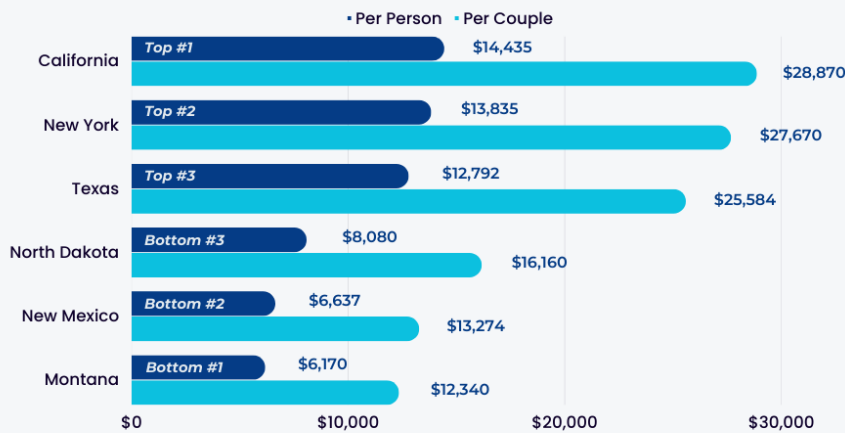

3. Mediator

The impartial individual conducting the mediation process and facilitating communication between the Parties.

4. Agreement
