

A tripped breaker is not automatically an emergency—it is a measured response designed by circuit protection standards to prevent dangerous overloads and faults. What Role Do GFCI and AFCI Specifications Play in Trip Events?

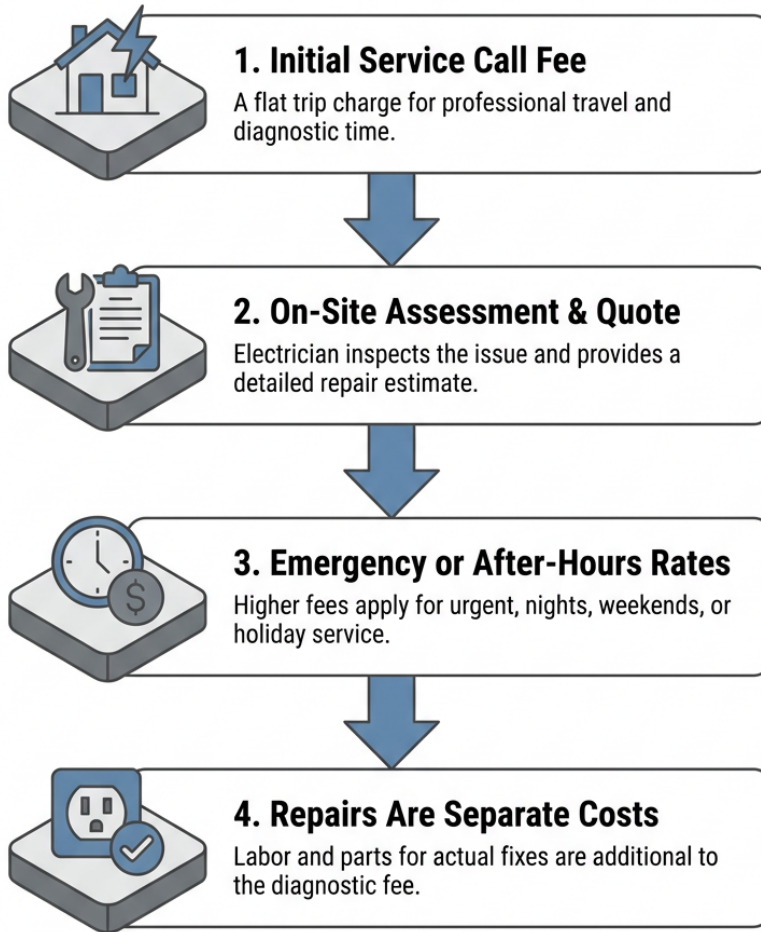

Conversely, if a breaker trips randomly with no obvious load increase, an arc fault or short circuit may be developing, which does warrant faster attention because it poses fire risk.
