

What the Anion Gap Calculator Measures

An **anion gap calculator** helps estimate the **serum anion gap**, a derived value used to gauge **electrolyte balance** and guide **acid-base status** assessment. It does not identify a single substance directly. Instead, it relies on common values from a **blood chemistry test** or **electrolyte panel** to estimate the difference between measured cations and anions in the **serum**.

Clinically, the anion gap is most useful when evaluating **metabolic acidosis**. A widened result can point toward unmeasured acids in the blood, while a normal result can reflect a different type of acid-base disturbance. Anion gap = sodium – (chloride + bicarbonate)

For example, if sodium is 140, chloride is 104, and bicarbonate is 24, the calculation would be $140 - (104 + 24) = 12$. This value becomes the **reference value** you use to check against the expected **reference range**.

Why these three values? Sodium is the principal measured cation in the sample, while chloride and bicarbonate are the major measured anions. Interpreting a High Anion Gap

A **high anion gap** usually means there are additional unmeasured acids in the blood. Common Causes of Abnormal Results

Atypical anion gap findings often indicate an disease rather than a problem with the formula itself. A increased gap may be linked to **kidney disease**, which decreases acid excretion and can contribute to metabolic acidosis. Impaired renal clearance can allow acids to accumulate, especially when kidney function is severely impaired.

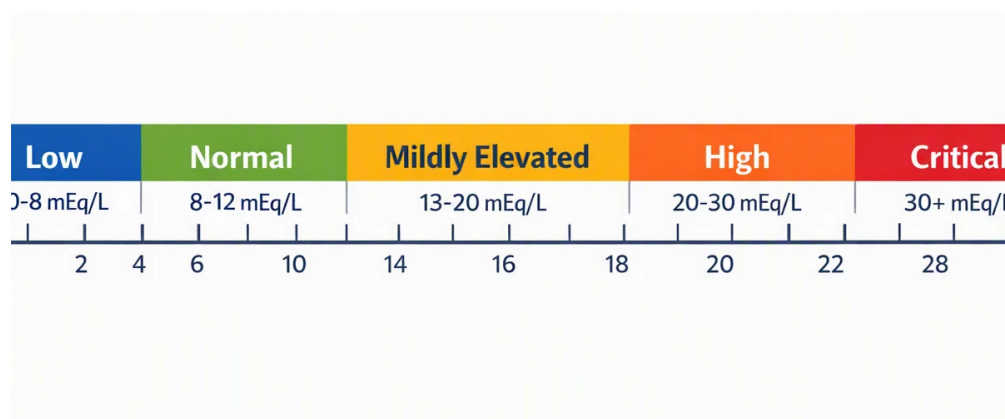
