

If you ride and a driver did not see you in Georgia, there is a prior you have to overcome.

Adjusters and jurors bring an assumption to these cases: that the rider was speeding, was lane splitting or weaving, or took a risk a car driver would not.

Sometimes that is accurate. More often a driver looked and did not register a single headlight.

These cases get built on physical evidence rather than narrative, since the story is doubted before it is told. The geometry of the turn carry more weight than either version of events.

Injury severity cuts both ways. There is nothing around a rider, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk by riding at all.
