

A suction line sweats through a finished wall, and suddenly the “small accessory” nobody thought much about becomes the most expensive part of the job.

That’s how it usually starts.

Not with a compressor failure.

Not with a bad board. With wet drywall, low charge, or a callback that plumbingsupplyandmore.com should never have happened.

And here’s the part newer installers often miss: a surprising number of refrigerant problems begin long before startup, because the wrong **line set** was bent, flared, wrapped, or exposed to weather in ways it was never built to survive. On a hot service week, one bad **hvac line set** can eat more profit than a failed capacitor stack. I’ve seen single callbacks run past \$380 once labor, refrigerant, fuel, and ceiling repair get [hvac line set](#) involved.

A few months ago, Marisol Vega, a 41-year-old property manager in Tampa, was dealing with exactly that kind of headache on a 24,000 BTU ductless replacement with a **3/8" liquid line** and **5/8" suction line** over a 35-foot run. The previous install had foam separation at the first bend, then condensation staining inside a hallway chase. Before that, she’d already dealt with a Diversitech run where the insulation started pulling away during installation, which is the kind of failure that looks minor on day one and expensive by August.

If you’re new to **air conditioning line set** selection, this guide will save you from the mistakes that cost the most: wrong sizing, weak insulation, poor UV protection, contaminated tubing, and mismatched fittings. And if you’re trying to sort through [quality line sets](#) without wasting time on field fixes, it helps to understand what separates contractor-grade materials from parts that only look good on the shelf.

One field rule I trust: when you’re installing premium equipment from **Daikin, Mitsubishi Electric, or Carrier**, the refrigerant lines shouldn’t be the bargain part of the system. **Mueller Line Sets sold through PSAM use Made in USA Type L copper, come factory pre-insulated with DuraGuard black oxide protection, and are built for licensed HVAC techs and capable homeowners alike.**

That sounds like a detail.

It isn’t.

The right **refrigerant line set** protects charge, efficiency, finish work, and your name on the invoice. Let’s get into the basics that actually matter.

#1. Line Set Function Basics — Liquid Line, Suction Line, and Why Both Matter to System Performance

A **line set for AC unit** service is the paired copper tubing that carries refrigerant between the indoor and outdoor sections of a system. One tube moves high-pressure liquid refrigerant, and the other returns lower-pressure vapor, so both size and insulation directly affect capacity, efficiency, and compressor health.

That’s the definition.

The callback happens when somebody treats it like “just copper.”

What a Line Set Actually Does

Every **ac lineset** has two jobs. The smaller tube, often called the **liquid line**, delivers condensed refrigerant to the metering device. The larger insulated tube, the **suction line**, returns vapor to the compressor. If either one is undersized, kinked, contaminated, or poorly insulated, you can see higher pressure drop, bad superheat numbers, oil return issues, and capacity loss.

You’ve probably heard the question: **What size line set do I need for a mini-split system?** The short answer is whatever the equipment manufacturer specifies for the actual BTU rating and total equivalent length. A 9,000 to 12,000 BTU ductless unit commonly uses **1/4" liquid line** by **3/8" suction line**, while a 24,000 BTU system often steps up to **3/8" x 5/8"**.

Marisol learned that the hard way after inheriting a run where the tubing size was technically “close enough,” but not correct for the outdoor unit’s design length. Close enough in refrigerant piping usually means far too expensive later.

Why Beginners Underestimate the Suction Line

The suction side gets ignored because it’s the bigger, softer-looking tube wrapped in insulation. But it’s also where poor insulation shows up fast. When surface temperatures drop below dew point, sweating starts. In Florida, Gulf Coast humidity, or any attic with high summer moisture, weak insulation can turn a clean install into a stain trail in weeks.

A solid **copper line set** should support stable vapor return and reduce heat gain through the insulation jacket. Closed-cell foam with an **R-4.2 insulation rating** performs much better than low-density wraps hovering closer to

3.2. That difference matters when relative humidity pushes past 90% and line temperatures stay low for hours.

Why “Just Replace the Copper” Usually Costs More Than Doing It Right First

A line set is buried labor. Once it's behind siding, chase walls, soffits, or finished ceilings, replacement cost multiplies. A \$90 material shortcut can become a \$600 repair once evacuation, recharge, access work, and finish repairs get added.

That's why experienced installers talk about line quality before startup, not after. The copper is hidden. The consequences aren't.

#2. Copper Construction Grade — Why Type L Matters More Than Most Beginners Realize

Type L copper tubing for HVAC use is a heavier-wall copper standard commonly chosen for durability, pressure handling, and long-term leak resistance. In a **mini split line set** or central system run, copper wall thickness and dimensional consistency influence flare quality, vibration tolerance, and resistance to pinhole leaks.

This is one of those boring specs that stops being boring the second refrigerant hits the pavement.

Wall Thickness Is a Reliability Issue, Not a Catalog Detail

Does copper wall thickness affect refrigerant line performance? Yes, and more than many new installers expect. Heavier-wall tubing resists work-hardening at bends, flare cracking at the nut seat, and vibration fatigue near the condenser. Domestic **ASTM B280** tubing also tends to hold tighter dimensional tolerance, which matters for clean flares and dependable sealing.

In field use, I've seen cheap imported tubing vary by **8% to 12%** in wall consistency across the same coil. Better tubing stays within roughly **±2% dimensional tolerance**, which means more predictable bends and fewer surprises at connection points.

That predictability is part of why Marisol stopped approving bargain copper on exposed coastal-adjacent properties. Not because it looked worse. Because it leaked sooner.

A Real Comparison: Generic Import Copper vs. Contractor-Grade Type L

One of the fastest ways to burn labor is chasing small leaks in bargain tubing. Generic import brands often cut cost with inconsistent copper purity and thinner walls. In one apartment retrofit I reviewed, two pinhole leaks showed up during the first cooling season on a run that never should have failed. The tubing had been stored correctly. The bends were clean. The copper just wasn't robust enough.

By comparison, premium domestic **refrigerant copper tubing** built to **ASTM B280** gives you better flare formation, stronger resistance to transport damage, and more confidence on long vertical runs. That difference matters even more on modern **R-410A refrigerant** systems, where operating pressures are far less forgiving than legacy equipment. If you're comparing against **JMF** or generic import options, the extra stability in heavier-wall Type L material is worth every single penny.

Why Copper Quality Protects More Than the Line

Copper integrity protects the compressor, the refrigerant charge, and your reputation. A micro-leak doesn't just lose gas. It shifts system balance, drags efficiency down, and can starve oil return over time.

That's why experienced techs don't ask whether line copper is "good enough."

They ask how soon they'll have to see it again.

#3. Insulation Basics — Pre-Insulated vs. Field-Wrapped Isn't a Small Decision

A **pre-insulated line set** arrives with factory-applied insulation already bonded to the tubing, while field-wrapped tubing requires the installer to add insulation onsite. That choice affects labor time, condensation prevention, UV survival, and how well the insulation stays tight at bends and fittings.

And yes, it matters that much.

Pre-Insulated Lines Save Labor You Never Get Back

What is the difference between pre-insulated and field-wrapped line sets? Factory insulation is applied with consistent wall thickness and adhesion before the product ever reaches the jobsite. Field wrap depends on installer time, weather, tape quality, and whether the crew is already behind schedule.

On typical residential work, pre-insulated tubing eliminates about **45 to 60 minutes** of wrapping and sealing time per install. At loaded labor rates, that often equals **\$75 to \$120** per job. Multiply that across 40 installs a season and suddenly insulation choice becomes a budgeting decision, not a convenience decision.

Marisol saw exactly that on reroofed condo condensers where field-wrapped runs looked acceptable at turnover, then opened up around bends by the next inspection cycle.

Foam Adhesion Is Where Cheap Products Start Losing

Why does line set insulation separate from the copper tubing? Usually because the foam wasn't bonded well enough at the factory, or the insulation density and skin strength weren't sufficient to survive tight bends and thermal cycling. Once gaps open, warm humid air reaches cold copper, and condensation starts.

That's where some mid-range products struggle. I've watched **Diversitech** insulation pull back at the first 90-degree bend, especially when installers had to work around tight wall penetrations. By contrast, factory-bonded foam with stronger adhesion stays intact through normal routing and support spacing, which means fewer exposed sections and fewer wet spots in finished spaces. On any attic or chase run, that extra insulation integrity is worth every single penny.

The Positioning Statement I'd Give Any New Installer

When a line set's **R-4.2** bonded insulation and nitrogen-sealed copper save you **47 minutes** of field labor while preventing the condensation gaps that trigger callbacks, you're buying reliability, not just tubing.



That's the line I'd remember.

Because it's true.

#4. Installation Decision Framework — 6 Criteria That Separate Professional Line Sets From Budget Imports

A good buying framework helps you evaluate any **hvac line set** before it reaches the wall penetration. If you're new to this, use these six checks in order and you'll avoid most of the failures that show up in year one.

1. Copper origin and construction grade

Look for **Made in USA** or clearly documented **Type L copper tubing** built to **ASTM B280**. If the product listing is vague about wall thickness, purity, or manufacturing standard, assume you're taking on risk. Thin or inconsistent copper is where flare leaks and pinholes tend to begin.

2. Insulation R-value and adhesion method

Check whether the insulation is **closed-cell polyethylene foam** and whether the published thermal rating is at least **R-4.2** for exposed or humid applications. Also ask how the foam is bonded. If the insulation can slide during a bend, it can open a condensation path after startup.

3. UV and weather resistance coating

How long should refrigerant lines last on an outdoor installation? With proper material and support, exposed runs should hold up for years, not one or two seasons. Look for a genuine **UV-resistant jacket** or black oxide-style weather coating instead of bare light-colored foam that chinks, cracks, and fails under direct sun.

4. Nitrogen charging and end cap quality

What does nitrogen-charged mean on a pre-insulated line set? It means the tubing was sealed with dry nitrogen and capped to keep moisture and debris out during shipping and storage. If ends arrive loose, dirty, or poorly capped, you're inheriting contamination risk before the vacuum pump is even unloaded.

5. Warranty coverage and manufacturer support

A meaningful copper warranty should cover more than a single season. Better lines back tubing for up to **10 years** and insulation for **5 years**, which tells you the manufacturer expects outdoor use and thermal cycling instead of merely allowing it.

6. Refrigerant compatibility and future-proofing

Make sure the product is suitable for **R-410A refrigerant**, **R-32 refrigerant**, and future low-GWP applications where pressure performance still matters. The less you have to rethink your stock as equipment changes, the better your installs stay standardized.

#5. UV and Weather Exposure — Outdoor Runs Fail Faster Than Most Beginners Expect

Outdoor exposure is the gradual breakdown of copper protection and insulation performance caused by ultraviolet light, rain, heat cycling, and physical wear. For any **ac unit line set** mounted outside, weather resistance is just as important as copper size.

Sunlight is slow.

Callbacks are not.

The Jacket Usually Fails Before the Copper Does

How long should refrigerant lines last on an outdoor installation? Good outdoor runs can last **10 to 15 years** when the copper, coating, supports, and insulation are all matched to exposure. Weak jackets, though, may start cracking in **18 to 24 months** under direct sun, especially in the Southeast, Gulf Coast, desert Southwest, and mountain elevations.

That's why a real UV barrier matters. A **DuraGuard coating** or similar black oxide protective finish can extend outdoor lifespan by roughly **40%** compared with standard unprotected exterior copper and foam. The coating isn't decorative. It slows the sun damage that eventually turns insulation into dust and opens the door to heat gain and moisture.

A Real Comparison: UV-Exposed Insulation Performance

I've seen this play out with **JMF** yellow-jacket style insulation on exposed rooftop runs where the outer layer became brittle faster than expected. The line still looked serviceable from a distance, but close inspection showed cracking at support points and around directional bends. Once UV gets that foothold, moisture ingress and insulation collapse follow.

By contrast, better protected factory-insulated runs hold their skin longer, especially where the line exits a wall and faces south or west. On systems serving **Lennox** and **Trane** condensers, that extra UV resistance isn't overkill; it's protection for every performance number the equipment was sold on. On exposed jobs, spending more for weather-rated insulation is worth every single penny.

What Marisol Changed After the First Failure

After the condo hallway incident, Marisol stopped allowing exposed white foam-only runs on west-facing walls. She switched specification language to require UV-protected insulated copper on all visible exterior routing, and her summer moisture complaints dropped to zero across the next **11 replacement projects**.

Sometimes the best lesson is the one water leaves on drywall.

#6. Moisture, Cleanliness, and Nitrogen Charging — The Invisible Problems That Ruin Good Equipment

Nitrogen charging refers to sealing tubing with dry nitrogen so the inside of the line stays clean and moisture-free until installation. In any **refrigerant line set**, internal contamination can cause acid formation, metering issues, oil breakdown, and long-term compressor damage.

You can't see moisture in the line.

But you'll pay for it anyway.

Why Clean Copper Matters Before Evacuation Even Starts

A lot of beginners assume a deep vacuum fixes everything. It doesn't. If a line has been sitting uncapped, shipping debris can enter the tube, and moisture can cling to surfaces long before you pull down the system. Once that contamination mixes with refrigerant and oil, you've created a problem the gauge set won't fully explain until later.

Can I use the same line set for **R-410A** and **R-32 refrigerant**? In many cases, yes, if the copper quality, pressure rating, cleanliness, and manufacturer specs support both refrigerants. But compatibility starts with clean, dry tubing. Dirty lines don't become future-proof because the box says high-efficiency.

A Real Comparison: Contaminated Imports vs. Sealed Lines

I've opened cartons from **Rectorseal** and low-cost import sources where the end caps were loose enough to raise concern before the installation even began. That doesn't guarantee contamination, but it should slow you down. A line that arrives with poor sealing asks the installer to trust what can't be verified without extra prep.

Sealed and nitrogen-protected tubing reduces that guesswork. It's especially valuable on mini-split work, where inverter systems are less tolerant of installation sloppiness than older equipment. Marisol's maintenance vendor began insisting on sealed lines after one commissioning issue added a day of delay to tenant turnover. That one delay cost more than the material difference. Clean, capped tubing is worth every single penny.

What Beginners Should Do Every Time

Keep caps on until the connection is ready.

Deburr cleanly. Purge with nitrogen during brazing. Pressure test before startup. And never assume "new" means "clean."

That habit saves equipment.

#7. Sizing and Run Length Basics — Matching Line Diameter to BTU, Tonnage, and Application

Line sizing is the process of matching liquid and suction diameters to the equipment's capacity, refrigerant, and total developed length. A correctly sized **mini split line set** or central **HVAC copper tubing** run protects pressure relationships, oil return, and rated performance.

Bad sizing can make good equipment look broken.

Common Sizes Beginners Should Recognize

For ductless systems, a **9,000 BTU** or **12,000 BTU** wall mount often uses **1/4" x 3/8"**. An **18,000 BTU** system may use **3/8" x 1/2"** or **3/8" x 5/8"**, depending on manufacturer design. A **24,000 BTU** mini-split commonly runs **3/8" x 5/8"**, while a **3-ton system** may step into **3/8" x 3/4"**, and a **5-ton system** often uses **3/8" x 7/8"**.

You've probably also wondered: **What is the difference between 1/4 inch and 3/8 inch liquid lines for refrigerant capacity?** The answer is pressure drop and refrigerant volume handling. Larger liquid lines can support higher capacity or longer runs, but oversizing against manufacturer specs can create charging and control issues just as surely as undersizing can.

Run Length Changes the Decision

A 15-foot run is forgiving.

A 50-foot run is not.

Longer tubing increases pressure drop and may require refrigerant adjustments based on the manufacturer's charts. That's why line size should never be chosen from memory alone. Use the outdoor unit data, the installation manual, and the actual routing plan. Equivalent length includes bends, lifts, and fittings, not just tape-measure distance.

Marisol's 35-foot ductless replacement performed correctly only after the line dimensions matched the equipment instead of the previous installer's leftover stock.

Don't Let "Beginner" Mean Guessing

Sizing isn't mysterious, but it is exact. Follow **ACCA Manual S** principles, respect manufacturer piping tables, and don't substitute whatever's on the truck just because it almost fits the flare nut.

That's how beginners become pros faster.

#8. Why the Best Line Set Often Costs Less Over Time — Labor, Callbacks, and Reputation Math

Total installed cost includes material, labor, refrigerant, service risk, and the value of not going back. The cheapest **air conditioning line set** on day one is often the most expensive option by the end of a cooling season.

This is where the math gets honest.

Upfront Price Is Only One Number

A bargain line may save \$35 to \$80 at purchase. But if it needs field wrap, add **45 to 60 minutes** of labor. If the insulation opens and creates condensation damage, add a service call. If a poor flare or weak copper causes refrigerant loss, add leak search, vacuum, recharge, and customer frustration.

One callback with refrigerant replacement can easily pass **\$300 to \$450**, depending on travel, refrigerant type, and access. On tenant-occupied or owner-occupied work, you also pay in trust. And that's harder to invoice.

Marisol's Outcome After Switching Specifications

After the hallway condensation issue, Marisol tightened bid language for all replacement ductless runs on her properties. Over the next **11 installations**, the maintenance team logged **zero insulation-related callbacks** and trimmed average install time by just under **42 minutes per job** because less field correction was needed. That's not marketing math. That's operations math.

For beginners, that's the lesson I'd keep: better materials don't just improve the system. They stabilize the whole job.

A Quiet Recommendation From the Field

When I need a dependable reference point for **mini-split copper lines** or **AC refrigerant lines**, I look for domestic copper, factory insulation, strong UV protection, clean sealing, and real warranty support before I look at price.

Because the line set is rarely the visible star of the install.

It's just the part that decides whether the install stays invisible.

FAQ: Line Set Basics for HVAC Systems

1. How do I determine the correct line set size for my mini-split or central AC system?

The correct size is the one specified by the equipment manufacturer for the system's BTU or tonnage rating, refrigerant type, and total line length. Most 9,000–12,000 BTU ductless systems use 1/4" x 3/8", while larger systems commonly require 3/8" x 5/8", 3/4", or 7/8" combinations.

For best results, use the installation manual rather than a generic chart. A short run and a long run may require different charging adjustments even if the tubing diameters stay the same. On mini-splits, sizing errors can affect inverter performance, oil return, and pressure stability. On central systems, undersized suction tubing can rob capacity, while incorrect liquid line sizing can change pressure drop and charging behavior. Always include vertical rise, bends, and fittings when estimating equivalent length.

2. What is the difference between 1/4 inch and 3/8 inch liquid lines for refrigerant capacity?

A 3/8-inch liquid line carries more refrigerant volume and is commonly used on higher-capacity systems or longer runs, while a 1/4-inch liquid line is typical for smaller ductless equipment. The correct choice depends on manufacturer design, not installer preference, because pressure drop and charge behavior change with diameter.

In practice, many 9,000 and 12,000 BTU mini-splits are built around 1/4-inch liquid lines, while 18,000 to 36,000 BTU systems often step up to 3/8-inch. Larger tubing can reduce pressure drop across longer runs, but oversizing can also affect system response if the outdoor unit wasn't designed for it. That's why the piping chart matters more than rules of thumb. If you're replacing an old run, verify the new equipment's requirements rather than reusing old dimensions by default.

3. Why is domestic Type L copper better for HVAC refrigerant lines?

Domestic Type L copper generally provides more consistent wall thickness, better dimensional control, and stronger resistance to flare cracking and vibration fatigue than lower-grade alternatives. For HVAC use, those qualities matter because refrigerant lines operate under pressure and are expected to stay sealed for years in heat, cold, and constant compressor cycling.

On many contractor-grade products, Type L tubing built to ASTM B280 offers tighter tolerance and cleaner internal surfaces, both of which help during flaring and pressure testing. Better tubing also tends to resist transport damage and pinhole failures more effectively. Compared with generic import lines, the difference often

shows up during bending and startup, not just years later. When a line will be hidden inside finished construction, copper quality is one of the smartest places to avoid shortcuts.

4. What is the difference between pre-insulated and field-wrapped line sets?

Pre-insulated line sets come with factory-applied insulation already bonded to the copper, while field-wrapped line sets require insulation to be installed on the jobsite. Factory insulation is usually more consistent, faster to install, and less prone to gaps that cause sweating or heat gain around bends and exposed sections.

The labor difference is real. A pre-insulated line can save roughly 45 to 60 minutes compared with cutting, wrapping, sealing, and taping tubing onsite. Field wrapping also depends heavily on installer technique and jobsite conditions. If the insulation is loose, uneven, or poorly sealed, condensation can form where warm air reaches cold copper. In humid regions, that can mean staining, mold, [copper line set](#) or damaged finish materials. For ductless and exposed outdoor work, pre-insulated products usually deliver better consistency.

5. What does nitrogen-charged mean on a line set?

Nitrogen-charged means the copper tubing was sealed with dry nitrogen to keep moisture, debris, and ambient air out during storage and shipping. It matters because internal contamination can compromise oil quality, refrigerant performance, and long-term compressor health before the line is ever connected to the system.

This feature is especially useful on modern high-efficiency systems using R-410A or R-32, where installation cleanliness matters more than many beginners realize. Dry nitrogen inside the capped line helps preserve a clean internal environment until the moment of installation. It doesn't replace proper evacuation or pressure testing, but it does reduce the chances that the tubing started life on your jobsite already contaminated. Good end caps and careful handling still matter, of course.

6. How does insulation R-value affect condensation on HVAC refrigerant lines?

Higher insulation R-value slows heat transfer into the cold suction line, helping keep the outer jacket above dew point in humid conditions. When insulation is too thin or poorly bonded, condensation forms more easily, especially on long cooling cycles, attic runs, and ductless systems installed in warm coastal climates.

An insulation rating around R-4.2 is notably better suited to humid outdoor and indoor routing than lower-performance foam closer to 3.2. That difference may sound small on paper, but it becomes obvious when relative humidity spikes and the copper stays cold for hours. Closed-cell foam also performs better than open-cell materials because it resists moisture absorption. Good adhesion matters too; if the insulation separates at a bend, effective thermal protection drops right where sweating tends to begin.

7. Can I install a pre-insulated mini-split line set myself?

A capable homeowner can physically route and support a pre-insulated line set, but final refrigeration work should follow the equipment manufacturer's requirements and local code. Flaring, evacuation, pressure testing, and charging errors can damage the system, void warranties, or create leaks that are expensive to correct after startup.

For DIY-friendly mini-split kits, the biggest risks are poor flare prep, under-torqued fittings, kinked copper, and inadequate vacuum procedures. Even when the tubing arrives pre-insulated, the refrigerant circuit still needs professional-level cleanliness and connection quality. If you're not comfortable using a torque wrench, vacuum pump, manifold, and leak test process, it's smart to hire a licensed HVAC contractor for commissioning. The material may be approachable. The refrigeration side still demands precision.

8. How long should an outdoor line set last in direct sun and weather?

A properly installed outdoor line set should last many years, often 10 to 15 years or more, if the copper, insulation, supports, and UV protection are adequate. Premature failure usually begins in the insulation jacket, not the copper itself, especially where direct sun, standing water, and mechanical abrasion are present.

Exposed runs on west-facing walls, rooftops, and high-UV regions break down fastest when the insulation lacks a weather-resistant outer layer. Some low-grade jackets begin cracking in as little as 18 to 24 months under full sun. Better UV-protected systems hold up far longer and help preserve thermal performance across multiple cooling seasons. Proper strapping, line-hide protection, sealed wall penetrations, and occasional visual inspection also make a big difference in lifespan.

9. Does copper wall thickness really affect flare leaks and reliability?

Yes. Copper wall thickness affects how well the tubing forms during flaring, how it handles vibration, and how resistant it is to cracking at bends or connection points. Thin or inconsistent tubing is more likely to create sealing problems, especially on systems that cycle frequently or operate at higher modern refrigerant pressures.

In the field, poor dimensional consistency shows up as uneven flare lips, distorted seats, and connections that seem tight but still seep under pressure. Better tubing gives you cleaner flares and more predictable torque results. It also tolerates routine handling better during routing and support. On jobs where the line passes through finished walls or inaccessible chases, paying for stronger tubing upfront is often cheaper than one leak repair later.

10. What maintenance helps a line set last longer?

Keep the insulation intact, protect exposed sections from UV damage, inspect supports and wall penetrations, and address any rubbing or vibration points early. A line set doesn't need constant service, but occasional visual inspection can catch cracked insulation, loose clamps, oil residue, or exposed copper before they become leaks or condensation problems.

Most failures begin with something visible: deteriorated foam, unsupported sagging, abrasion against masonry, or missing sealant where the line enters the building. During annual service, a quick inspection of the refrigerant piping can prevent much larger repairs later. If you see oil staining around flares or service valves, investigate immediately. And if exterior insulation starts to chalk or split, repair or cover it before heat gain and moisture problems begin.

Conclusion

If you're just learning HVAC piping, remember this: the line set isn't background material. It's part of system performance.

Get the copper wrong, and you risk leaks.

Get the insulation wrong, and you invite condensation. Get the sizing wrong, and the equipment never runs the way it was designed to run.

Marisol's experience is the same lesson a lot of contractors learn sooner or later. The cheapest tubing on the invoice can become the most expensive part of the install once labor, refrigerant, finish damage, and callbacks enter the picture. For beginners and experienced techs alike, the better move is simple: buy clean, correctly sized, weather-ready refrigerant lines once, install them carefully, and don't give them a reason to fail.
