

If you were riding and were hit around Atlanta, the assumption is already working against you.

There is a built in bias in motorcycle claims: that the rider was going too fast, was weaving through traffic, or accepted a risk nobody else would.

Occasionally that is true. Usually the car turned left across a rider who had the right of way.

These cases get built on physical evidence rather than narrative, since the story **personal injury attorney** is doubted before it is told. The geometry of the turn do the arguing.
