Common Concrete Sidewalk Problems in NYC

Broken Edges and Corners

Sidewalk corners and edges are vulnerable to impact and weather exposure. They may chip, crumble, or break over time.

Small localized damage may sometimes be repaired with appropriate materials, while severely deteriorated edges may require partial or complete slab replacement.

Surface Scaling and Deterioration

Scaling occurs when portions of the concrete surface begin to flake, peel, or deteriorate. Moisture, freeze-thaw exposure, material problems, and installation conditions can contribute to surface deterioration.

The correct repair depends on the depth and extent of the damage. A professional contractor can assess whether the issue is limited to the surface or extends deeper into the concrete.

What Causes Sidewalk Cracks and Damage?

Freeze-Thaw Cycles
