

If you were hurt on someone else's property in the Atlanta area, the claim is not as simple as it looks. Showing the spill was there is only half of it.

Under Georgia law you generally have to show that the property owner knew about the hazard, created it, or would have discovered it by inspecting the way [truck accident lawyer](#) a careful owner should.

This is the reason the first days matter so much. Store video does not last long, and once it is gone there is no way to show how long the hazard sat there.

The report the store writes are written by the party you will be making a claim against, which shapes what they contain. The store's own inspection records are just as important, because a policy nobody followed is its own kind of evidence.
