

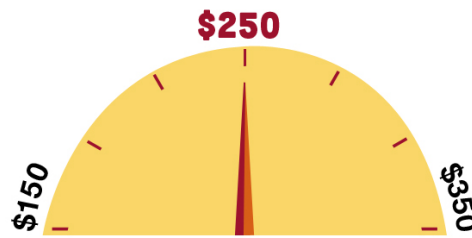

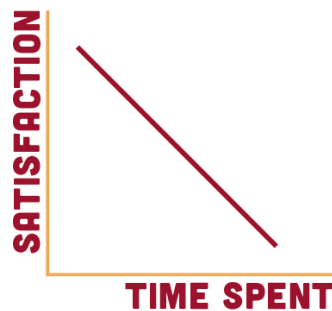
Wedding > Divorce
