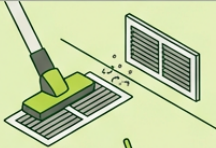
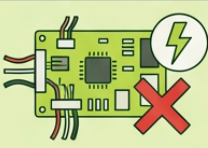


The 20 rule in HVAC refers to the requirement that return-air duct size must be at least 20 percent larger than supply-air duct size to maintain balanced airflow and prevent static pressure buildup.
