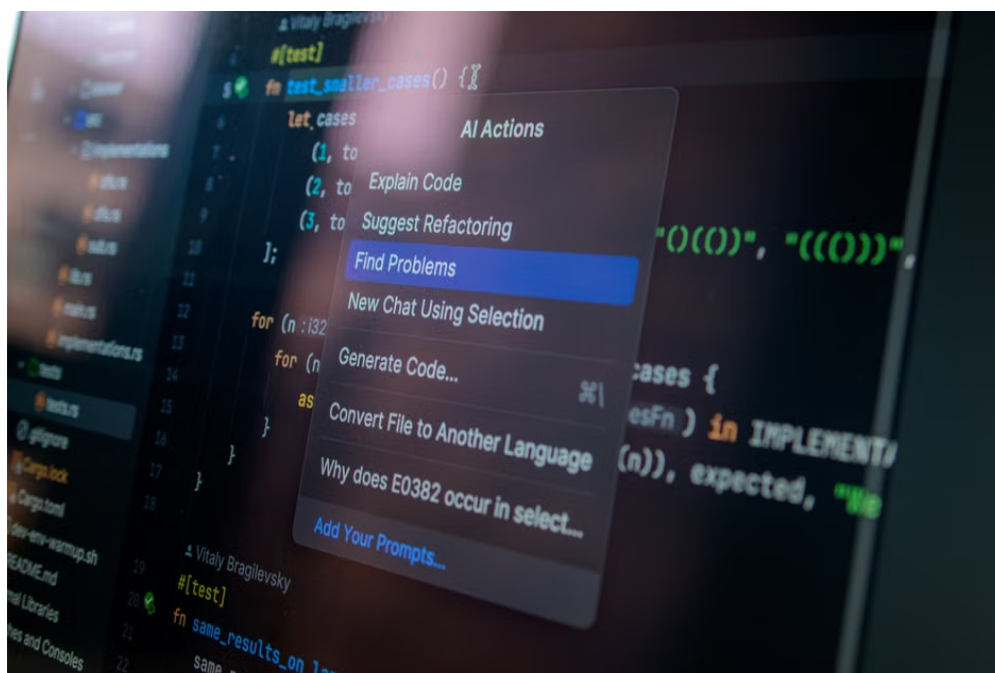
Key Positioning Differences
