

If you or your child were bitten in the Atlanta area, the legal standard surprises most people.

Some states hold the owner responsible no matter what. Georgia does not work that way. The claim generally turns on whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

The ordinance route is frequently more provable, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.
