

A rideshare wreck raises a question a normal car crash does not: which insurance policy actually applies. The answer depends on what the driver was doing at that exact moment.

If the app is off, it is an ordinary car wreck, and only the personal policy is in play. When the app is on and they are waiting for a ride request, a smaller layer of coverage generally applies. Once they have accepted a ride or have a passenger in the car, a far larger commercial policy usually applies.

That timing is not a technicality. It can decide whether the coverage available is modest or substantial, and the records that prove it sit with the rideshare company, not with you.

Whether you were riding, driving another car, walking or on a bike changes the analysis too. Each position can reach a different layer of coverage.
