At the MIAM we can perform a preliminary, a measure check of Lawful Help eligibility however please note that this meeting cost can not be reimbursed.

Do both moms and dads need to go to a MIAM?

If you determine to go to court, you'll typically require to show you've participated in a MIAM prior to you apply. If you participate in a MIAM yet your ex-partner does not, you can still relate to litigate. You will not need to go to a MIAM in some conditions, as an example if there's been domestic abuse.

Others consist of the Family Mediator's Organization and National Household Mediation, and the Family Members Mediation Section of the Civil Arbitration Council.
