

If you were injured in a fall in the Atlanta area, there is more to it than the hazard itself. Showing the spill was there is only half of it.

Georgia law generally requires that the property owner knew about the hazard, caused it themselves, or should have found it through reasonable inspection.

That is why moving early matters. Surveillance video does not last long, and once it is gone there is no way to show how long the hazard sat there.

Incident reports come from the business itself, which shapes what they contain. The store's own inspection records matter just as much, since a written policy that was ignored says a great deal.
