

When someone is shocked or burned on a job site in Georgia, several companies may share responsibility.

There is the property owner, a general contractor, the electrical subcontractor, sometimes the utility, sometimes an equipment manufacturer, and sometimes a labor supplier. Each has different insurance and different incentives to point at the others.

If the injury happened at work, workers compensation covers medical treatment and part of your lost wages, and it bars ***experienced lawyer for truck accident*** a suit against your employer. It does not bar a claim against a third party whose conduct created the hazard.

The claim against the other company is normally where the meaningful money is, since comp covers none of the human loss and only part of the financial one.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, none of which an injured worker can obtain by asking.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
