

When a family loses someone in a preventable wreck, the legal question is not the first thing on anyone's mind. It becomes one later, usually when the bills arrive or an insurer calls.

Georgia treats a death case differently than people tend to assume. There are generally two separate claims. One belongs to the surviving family and covers what [Discover more here](#) the law calls the full value of the life that was lost. The other belongs to the estate and covers the last medical expenses, the funeral, and any conscious pain before death.

Who may bring the first claim follows an order set by statute. A surviving spouse generally comes first, then children, then parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor on the spouse's share.

Deadlines apply, and some are shorter than people [truck accident lawyer](#) expect. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also thins out, particularly where a commercial vehicle or a business is involved.
