

If you or your child were bitten in Atlanta, Georgia works differently than people expect.

In some places an owner is liable automatically. Georgia is not one of them. Usually it comes down to whether the owner knew the animal was dangerous, or whether a leash law was being broken at the time.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

Local ordinance violations are usually easier to establish, [atlanta personal injury attorney](#) which is why the first questions are about where the dog was and whether a complaint was ever filed.

This evidence does not last. Animal control files and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.

## **How much does a personal injury lawyer cost in Atlanta?**

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. ## **How long do I have to file an injury claim in Georgia?**

Georgia generally gives an injured person two years from the date of the injury to file a personal injury lawsuit, and a claim against a city, county or state agency can require written notice far sooner than that. Waiting also makes proof harder to collect, because records and camera footage do not last forever. Flanagan Law, P.C. reviews the deadlines that apply to a specific Atlanta case at no cost.

## **What should I do after a truck accident in Atlanta?**

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
