There is also a less obvious layer to first impressions: how the space handles different customer intents. Some shoppers know exactly what they want and want to be in and out in five minutes. Others need ten or fifteen minutes to compare options, especially if they are shopping for sleep support, pain management conversations within legal retail boundaries, or lower-dose edible products. The best stores create room for both types of visitors.

Product selection is not about having everything

Others know a lot but overwhelm customers with jargon. The sweet spot is informed translation. For example, if a customer says they stopped using cannabis years ago because edibles felt too intense, a strong staff member will not just point at a gummy wall and say, "Try these." They will likely ask about tolerance, desired effect, timing, and previous dose. Then they might steer the customer toward a 2.5 to 5 milligram option with a clear onset explanation and a suggestion to wait before taking more. That kind of guidance prevents bad experiences.

Knowledge should also be specific. If someone asks what makes two vape carts different, "This one is better" is not enough. That may seem basic, but it is the foundation of repeat business. Customers forgive an occasional stockout. They do not forgive feeling misled.

The menu should help, not intimidate

A lot of cannabis menus still feel built for insiders. They assume familiarity with abbreviations, strain families, extraction techniques, and potency shorthand that many shoppers simply do not have.

FAQ About Cannabis Store Lyons

How much can a non-resident buy from a dispensary in Colorado?

Colorado residents 21 and older can purchase up to one (1) ounce marijuana from a licensed retailer. Non-residents can purchase up to 1/4-ounce at a time.

What is the highest mg edible you can buy in Colorado?

In Colorado, the maximum THC content you can buy in a single recreational edible package is 100 mg, with individual servings capped at 10 mg. However, registered medical marijuana patients can purchase up to 20,000 mg per transaction with a valid medical card.

Can you go to two dispensaries in one day in Colorado?

You can visit multiple dispensaries in a single day — but your purchase limit applies statewide, not per store. Colorado's cannabis tracking system (Metrc) monitors purchases across all licensed retailers.
